PREAMBLE

In the name of the Beneficent God of all, we the Wives, Widows, Mothers, Grandmothers, Sisters, Daughters, Grand-daughters, Stepmothers, Stepdaughters, Daughters-in-Law and Aunts of the men and women, who have honorably served, or are serving our Country in the United States Marine Corps, or a United States Navy Corpsman currently serving or who has trained with Marine FMF Units in excess of ninety (90) days and earned the Marine Corps Device or Warfare Device worn on the Service Ribbon Authorized for FMF Corpsmen, and Women Marines (former, active and Reserves), and Associate Members, for the common good of this Nation, and all the Nations and people of our World, and in order that the fundamental rights and freedom of every person may be preserved, to foster interest in the affairs of the United States Marine Corps and the Marine Corps League, Incorporated, to protect and advance the welfare of the wounded and disabled Marines and their dependents, and for the further purpose set forth hereinafter, do solemnly and firmly associate ourselves together in a nonprofit corporation known as the "Marine Corps League Auxiliary", and ordain and establish these Bylaws under authority to a Charter duly granted by the National Headquarters of the Marine Corps League, Incorporated.
